Impact 100 Palm Beach County

Helen Ballerano - The main points for Impact are as follow:

1. Impact 100 PBC awards \$100,000 grants to nonprofits that serve our geographical area which extends from the Broward County line to the south up to Lake Worth Road to the north. The nonprofits must be an established 501(c)3 for at least 3 years in order to apply. Nonprofits may apply in one of the five focus areas: arts & culture, education, environment, family and health & wellness. Impact 100 seeks to fund new initiatives or program enhancements and not "business as usual".

2. This year we are excited to announce that if we sustain our membership of 500 members or more we will award a \$100,000 grant in **EACH** of the focus areas.

3. The **LOI is now open** and nonprofits must be registered with the Community Foundation for Palm Beach and Martin Counties in order to apply. Register by going to www.yourcommunityfoundation.org. The **LOI closes on October 27th**.

4. A Nonprofit Workshop on the Impact grants process is scheduled for **Thursday, September 29th, 2:00 pm, at the Hagen Ranch Branch of the Palm Beach County Library**. Registration is requested and can be done online at www.impact100pbc.com and then go to the **Our Events** link.
